Fitness-For-Duty and Return-To-Work

A fitness-for-duty (FFD) medical evaluation is typically triggered by an unexpected incident involving an employee, such as an accident, witnessed or reported unusual behavior, or concern that health or medications may pose a threat to health or safety in the workplace.

An FFD examination is an open-ended medical evaluation that may include multiple components. The goal is to ensure that the employee can safely return to work without posing a threat to his or her health, coworkers, or the public.

A return-to-work (RTW) medical evaluation is an evaluation of an employee who has been out of work due to a medical condition (often resulting in a short-term or long-term disability leave). The intent of such an evaluation is to ensure that an employee can safely return to work without posing a threat to his or her health or without posing a threat to coworkers, the public, or the workplace.

The RTW evaluation is an open-ended medical evaluation by the employee's physician.
